

Reasonable Accommodation: A request for reasonable accommodation is for persons with disabilities seeking equal access to housing under the Federal Fair Housing Act and the California Fair Employment and Housing Act in the application of zoning laws and other land use regulations, policies, and procedures.

- A. A request for reasonable accommodation may include a modification or exception to the rules, standards, and practices for the siting, development, and use of housing or housing-related facilities that would eliminate regulatory barriers and provide a person with a disability equal opportunity to housing of their choice.
- B. A reasonable accommodation is granted to the household that needs the accommodation and does not apply to successors in interest to the site.
- C. A reasonable accommodation may be granted in compliance with this chapter without the need for the approval of a variance.
