<u>Project Description:</u> The Applicant is requesting the installation of an electrified fence surrounding a proposed secured parking area. An AUP is required for any electrified fencing within an M-1 (light industrial) zoning designation. The permit is only required for the electrified fence portion. The proposed secured parking area does not require permitting from the Planning Department and is not included as part of this Administrative Use Permit. The Applicant must still receive approvals from the Building and Safety Division as well as the Sacramento Metro Fire Department.
