## A. AT&T TELECOMMUNICATIONS FACILITY - PROJECT NO. DD8085 - LIMITED USE PERMIT.

The applicant is requesting a Limited Use Permit that would allow the installation of a 93 foot tall monopole with 12 panel antennas at two levels, 2 future microwave dishes and an 11 ½ foot by 28 foot prefabricated shelter with propane tank and a generator, enclosed by a solid redwood fence.

Zoning: General Commercial (GC)

Project Planner: William Campbell, Principal Planner

Recommendation: Staff recommends the Principal Planner determine the project Categorically Exempt under Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act Guidelines, and approve a Limited Use Permit for the proposed project, subject to the submitted Project Plans and Conditions of Approval.
