<u>Project Description:</u> The applicant is requesting Minor Design Review approval for approximately 180 feet of partial façade renovations for the previously occupied Kmart store. The façade improvement would reface the old store front with faux columns and projections to enhance the new store front. The new design would extend architectural parapet details above the existing roof line to provide a new entry marquee. This project would be the first phase of several renovations to improve the whole Rivergate Center.
