1. CALL MEETING TO ORDER

3. PUBLIC HEARING

A. RIVERGATE FAÇADE - PROJECT NO. DD8445 - MINOR DESIGN REVIEW.

The applicant is requesting Minor Design Review approval for approximately 200 feet of partial façade renovations for the previously occupied Kmart store. As proposed, the façade will be upgraded to create two tenant spaces for a total of three tenant spaces within the old building. The design uses faux columns and projections to enhance both new store fronts. One tenant will also use low walls to create spaces for shopping cart storage on either side of the entry. New architectural parapet details above the existing roof line will be added to provide entry marquees and additional visual interest. This project is the second phase of renovations to the entire Rivergate Center.

The proposed monument sign will replace the existing wooden sign in the same location. The proposed electronic monument sign meets all applicable size, height, setback, and illumination standards in the Zoning Code.
