As described in the application, the existing Cordova Neighborhood church would like to include adult day care service with their establishment Monday through Friday from 9:30 a.m. to 2:30 p.m. This proposed service would provide care for persons suffering from a variety of ailments (stroke victims, Alzheimer's disease, etc.) for a maximum of 25 people at one time. No physical improvements to the site are proposed as the adult day care service will be located in rooms previously used for the church's child day care service that was approved by the City of Rancho Cordova in 2005.
